The most popular routes for **Golden Visa** Include:



Investors in Public Interest

Deploy **AED 2 Million** in an approved investment fund, deposited in the UAE, and not financed by a loan.



Real Estate Investors:

Purchase property of a minimum of **AED 2 Million**, from either one or multiple residential properties, as long as the down-payment is complete. This can include off-plan properties & they may be mortgaged.



Special Talent Executive Directors

Show a minimum monthly salary of **AED 30,000** and have a relevant degree, with at least 5 years of relevant experience.



The Golden Visa program takes roughly 1 Month to process and applicants must remain within the country until it is completed.

Alternatively, the **Investor Visa** is available for individuals that own real-estate property in UAE but do not meet the AED 2 Million criteria. This visa can be issued for a period of 2-5 years subject to the property evaluation.

Similarly, the **Green Visa** is a form of self-sponsorship for Freelancers or Self-Employed individuals, valid for a period of 5-years, with either proof of financial solvency or degree and salary of not less than AED 15,000 per month.
