Application Process & Eligibility

The application process for São Tomé and Príncipe's Citizenship by Investment program is designed to be straightforward, efficient, and transparent. Investors can obtain citizenship by making a qualifying contribution, provided they meet the program's due diligence and documentation standards. The process is managed directly by the government in partnership with authorized agents, ensuring every application receives fair and thorough evaluation.

Eligibility extends to main applicants over 18 years old, along with their spouse, dependent children, and in some cases, dependent parents. All applicants must demonstrate a clean criminal record, good financial standing, and proof of legitimate source of funds.
